

Infertile couples can apply for govt's **ART subsidy scheme from Sunday**

Health Bureau (SSM) Deputy Director Kuok Cheong U said yesterday that the government has launched a subsidy scheme for assisted reproductive technology (ART) services to help couples who have difficulties in procreation, which will open for applications from Sunday, according to an SSM statement yesterday.

Dr Kuok made the remarks in a briefing session introducing the scheme yesterday, adding that applicants must be married couples or those in a domestic partnership in Macau, the statement said.

ART services will be provided by the Islands Healthcare Complex - Macao Medical Centre of Peking Union Medical College Hospital (PUMCH), (Macao Union Hospital), the statement said, adding that applicants can apply at the public Conde de São Januário Hospital Centre, and successful applicants will be provided with prior clinical assessment to ensure that they meet the conditions and referral criteria for ART.

Macao Union Hospital obstetrician and gynaecologist Ku Sio Kuan underlined that the government's scheme does not include third-generation technologies but the first two generations, as the first-generation In Vitro Fertilisation - Embryo Transfer (IVF) technology mainly targets female infertility, mainly ovulation dysfunction, fallopian tube

obstruction, or uterine displacement, which patients with abnormal genetic diseases, the accounts for about two-thirds of all infertile couples, the statement said.

Meanwhile, the second generation of Intracytoplasmic Sperm Injection (ICSI) is mainly for men with sperm problems, accounting for about one-third of the infertile patients, Ku said, adding that thirdgeneration technology is mainly used from the perspective of eugenics and applicable to

statement said.

However, Dr Ku said the scheme would not be applicable to patients with recurrent miscarriages directly related to genetic diseases and which require prenatal diagnosis and genetic counselling, according to local media reports.

Macao Union Hospital Deputy Director Lei Wai Seng said at yesterday's briefing

session that eligible applicants can be exempted from the fee twice, and he also underlined that the causes of infertility are many, such as if the applicant's own underlying disease causes infertility, the applicant needs to lose weight, get his or her diabetes under control, as otherwise the costs of treatment of other chronic diseases are not covered by the fee waiver, according to local media reports about the briefing.

Representatives of the Women's General Association of Macau (commonly known as Fu Luen, its name in Cantonese) attending the session expressed concern about the applicability of the scheme for the second child.

Dr Lei said the purpose of the scheme was to encourage childbirth, and that women who already have given birth to children can still apply for the scheme, and that the government's aim was for the public to "have one more child if they can".

Dr Kuok also said he believed that there will be no more than 100 applicants per year, adding that right now there are about 200 women receiving treatment at the infertility clinic of the public Conde de São Januário Hospital Centre, according to local media reports.

Businessman gets 18 years in jail for bank fraud

Macau businessman Liu Haigui was yesterday sentenced in absentia to 18 years behind bars for defrauding The Macau Chinese Bank (MCB) out of about 456 million patacas, but all the other 14 defendants in the case were acquitted, including the bank's former president Yau Wai Chu, according to reports by local journalists who attended the sentencing.

Five defendants who had been remanded in custody for about a year, including businesswoman and newspaper publisher Bobo Ng Son Po, were released from detention yesterday.

The Court of First Instance (TJB) ruled that, with the exception of Liu, the Public Prosecution's bank loan fraud allegations

concerning the defendants could not be proved, because of which they were acquitted of all charges which included organised crime, forgery and fraud.

In the wake of his prison sentence, an arrest warrant for Liu has been issued.

The defendants included five former employees of the bank.

According to a statement by the Court of Final Appeal, which oversees Macau's lower courts, the case involved multiple "complex bank loan frauds" by Liu who

presented forged documents and false construction project contracts to the bank to obtain the loans.

The statement did not identify any of the defendants, merely referring to them as, for instance, "No.6 defendant" or "businessman A". It identified the bank's former executives who stood trial as "No.1 to No.5 defendants".

All of the defendants, including Liu, were acquitted of their organised crime charges. Liu, which the statement referred to as "No.6 defendant", committed 13 crimes of fraud involving "considerably high amounts of money" and three crimes of using false documents, the statement said.

It was not immediately known whether the Public Prosecution (MP) plans to appeal. \blacksquare

Police bust 2 illegal currency exchange cases

The Judiciary Police have separately arrested a woman from the mainland and three male mainlanders for engaging in illegal currency exchange transactions, Judiciary Police (PJ) spokesman Lei Chi Hou said during a special press conference yesterday.

In the first case, the 37-yearold woman surnamed Zhong is a farmer.

On Thursday, Zhong offered an illegal currency exchange deal to two gamblers outside a Cotai casino. After Zhong transferred 67,900 yuan to one of the gamblers, they handed HK\$70,000 in cash to Zhong's accomplice who then left the scene.

Subsequently, when the gambler who had received the funds attempted to share the money with his companion via a bank transfer, the bank rejected the transaction. This led him to suspect the involvement of illicit activities in the transfer he had received, prompting him to report the case to the authorities.

Zhong was apprehended on the spot, while the two gamblers cooperated as witnesses in the investigation. It was later revealed that the bank had declined the

male suspects were involved in defrauding a mainland woman out of HK\$100,000 last week through an illegal currency exchange deal. They transferred 93,500 yuan, which allegedly consisted of fraudulently obtained funds, to her account, leading to the freezing of her account.

The four suspects in the two cases have been transferred to the Public Prosecutions Office (MP), facing illegal currency exchange charges, while the trio in the second case also face fraud charges.

Health Bureau urges public to be wary of chickenpox virus

The Health Bureau (SSM) said in a statement yesterday that the chickenpox virus in Macau has become more active recently, with a weekly average of eight cases since the first of this month, rising to 40 cases last week, which is much higher than the three cases in the same period of last year, and called for vigilance from parents, educational institutions and childcare centres.

The statement said that two cases of chickenpox cluster recently reported by Colégio de Santa Rosa de Lima - Secção Inglesa and Colégio Dom Bosco (Yuet Wah), with a total of 18 patients who had received one dose of varicella vaccine.

These patients have shown symptoms of red rash and blisters on the head, face, limbs and chest and back since last Sunday, all of them have no serious illness or other serious complications.

Between the beginning of this year and yesterday, a total of 355 chickenpox cases had been recorded in Macau, representing a times to 25, the statement said.

year-on-year increase of 134 cases, the statement said, adding that six cases required hospitalisation and were discharged from hospitals after recovery, and there were no serious and fatal cases. About three quarters of the cases were children, with most of them aged 8 to 17.

In addition, the bureau recorded a total of 449 cases of mandatory declaration of diseases last month, a decrease of 32 cases compared with September, according to the statement.

Among respiratory diseases, there were 88 cases of influenza, a month-on-month decrease of 57 cases, and a significant decline from the 2,699 cases recorded in the same period last year, the statement said.

In October, number of salmonella infections decreased by 41.1 percent to 33, while the number of scarlet fever infections increased by 47.2 percent to 53, and the number of Norwalk-like virus infections decreased by 52 percent to 13, while the number of chickenpox cases increased by 1.8



married in 2009 and divorced in 2018 were taken last week to a police station for questioning about their alleged sham marriage, Public Security Police (PSP) spokesman Lei Chan Hong said yesterday.

Both suspects are in their fifties. The male suspect surnamed Zhang told the police that he's a businessman, while the female suspect surnamed Ho is a casino dealer. Zhang is originally from the mainland.

According to Lei, the pair became acquainted in 2000. In 2009, Zhang suggested to Ho that they enter into a fake marriage, offering her 80,000 patacas. Ho agreed to the arrangement.

Their "marriage" ended in 2018 to Lei.

Zhang decided to legally marry his fiancée from the mainland, with whom he has two children, in order to help her and their children acquire Macau identity cards. The Identification Services Bureau (DSI) suspected the previous "marriage" to be a sham and subsequently referred the case to the Public Security Police. Police intercepted the duo last week and took them to a police station for questioning.

The two suspects told the police that they had never had a "real" relationship together.

The duo have been transferred to the Public Prosecutions Office (MP), facing document forgery and false statement charges, according



Police nab mainland duo for theft-by-finding

A man and a woman from the mainland have been arrested for stealing a camera that they found on the street, Public Security Police (PSP) spokesman Lei Chan Hong said at a regular press conference yesterday.

The female suspect is surnamed Lin and the male suspect is surnamed Zhong. Both are in their forties and they came to Macau as tourists.

According to Lei, the police received a report from a woman in August saying that she had lost

her camera worth 5,700 patacas in a Cotai casino.

Under questioning, they admitted to stealing the camera out of greed.

Govt rejects US letter slandering HK's reputation

HONG KONG - The Hong robustness of the city's financial Kong government yesterday strongly disapproved and opposed a letter from US politicians to the country's treasury secretary, saying that it damages the special administrative region's (SAR) reputation as an international financial centre.

A HKSAR government spokesperson stressed that the allegations had no factual basis and the letter was a "crude and reprehensible attempt to spread lies and misinformation about Hong Kong for personal political gain".

He said the government "has been enforcing the sanctions imposed

Govt to build footbridge linking Fai Chi Kei's waterfront and residential area

The government will build a footbridge across a junction in Fai Chi Kei district near its waterfront, the construction of which is expected to get off the ground before the second quarter of next year, making it more convenient for pedestrians to walk between the waterfront's sittingout area and the district's residential neighbourhood, the Public Works Bureau (DSOP) said yesterday.

The L-shaped footbridge will be located at the junction of Rua Norte do Patane (沙梨頭北街) and Rua do Comandante João Belo (俾若翰街/ 筷子基北街), linking the current sitting-out area along the east-side waterfront of Patane North Bay on one side with residential estates on the other side.

Patane North Bay, a bay off Fai Chi Kei and Ilha Verde, is known as Fai Chi Kei North Bay in Cantonese.

The government is currently building a new sitting-out area along the south-side waterfront of Patane North Bay, which is slated to be completed before the end of this year, after which it will be connected with the current sittingout area along the bay's east-side waterfront.

The current sitting-out area there is officially known as Fai Chi Kei North Bay Recreational Area.

A DSOP statement yesterday noted that the new L-shaped footbridge will have three assess points, namely one at the Fai Chi Kei North Bay Recreational Area, one outside the Weng Hoi Building (宏開大廈) residential estate, and

one outside the Fai Tat Building (快達樓) social rental housing estate.

The statement said that the footbridge will be equipped with a lift, an escalator, and a staircase at each of the three access points.

The L-shaped footbridge's section crossing Rua Norte do Patane, between the waterfront sitting-out area and Weng Hoi Building, will be 50 metres long, while its section crossing Rua do Comandante João Belo, between Weng Hoi Building and Fai Tat Building, will be 40 metres long, the statement said.

The government launched a public tender at the end of last month for the footbridge project. Potential bidders were required to submit their quotations by Monday.

A total of 11 construction companies had submitted their bids, which were unsealed by DSOP officials yesterday. All bids were accepted.

Yesterday's DSOP statement announced that the quotations proposed by the 11 bidders range

from 46 million to 63 million patacas. The bureau has set a maximum

period of 500 working days for the winning bidder to complete the project.

Yesterday's statement also said that the construction periods proposed by the 11 bidders are identical, 450 working days.

The statement said that the construction of the footbridge is expected to get off the ground before the second quarter of next year.

The statement said that the new footbridge will create a walking environment that separates pedestrians from vehicular traffic, making it more convenient for pedestrians to walk between the district's waterfront sitting-out area and residential estates.

In addition to the current sittingout area along the bay's east-side waterfront, in the vicinity there is another sitting-out area, located between the Weng Hoi Building residential estate and its adjacent Weng Ken Building (宏建大廈) residential estate.
